## GC Rule of the Month

## 11.2.3 Ball Striking Faults

"A fault is committed by a player, who, during the striking period, strikes a ball with any part of the mallet other than an end-face of the head, either deliberately in any stroke or accidentally in a stroke that requires special care because of the proximity of a hoop or the peg or another ball."

This rule was amended in the 6<sup>th</sup> edition to clarify the difference between deliberate and accidental use of a part of the mallet other than an end-face of the head.

Players should make particular note to take care in attempting strokes when there are obstacles close to the striker's ball, as a misshit results in a fault.
