AC Club Teams Event

The Epsom-Remuera Croquet Club hosted the AC Club Teams Event on Labour Weekend with Epsom-Remuera CC, Whakatane CC, Wellington MCC and Waireka CC competing against each other in teams of six. AC & GC Country Rankings

The WCF's quarterly team rankings were updated at the end of September.

In AC, the top 4 remains unchanged with New Zealand staying in third place. Wales and Ireland have both moved up a place to 5th and 6th respectively, while Scotland have dropped to 7th.

AC Law of the Month

8.4 Cancelling a Stroke

"The striker may cancel the stroke and the striking period after they have started and before the stroke is played by:

8.4.1.1 stepping away from the stance under control; or

8.4.1.2 stopping or diverting the mallet, after having begun to swing it for the purpose of striking the striker's ball, in a successful attempt to avoid hitting the ball or committing a fault."

This rule was introduced in the 7th edition of the Laws to clarify the difference between cancelling and annulling a stroke. The above rule refers to cancelling, in which a player makes no contact with the ball.

In this case, the striker is entitled to begin the *stroke* and *striking period* again.
