LETTER FROM THE BOARD CHAIR



During the year we received the resignation of two of CNZ's four staff. Inclusion Officer, Oliver Field, accepted a position with the Westport Council in September 2024. We wish him well in his new appointment and are grateful for his work in establishing links with a number of disability groups. Several Associations have organised competitions with these groups, and we are grateful that they are maintaining Oliver's initiatives. The more serious resignation is that of Stefan Horrer, our Chief Executive. Stefan joined CNZ in August 2022 and is leaving in October 2025. His leadership skills and dedication to the role will leave CNZ as a more professional and growing organisation and I much regret his decision. So good luck, Stefan, with your new endeavours and

your croquet playing. The Board is also grateful to the Office Administrator who has agreed to extend her working hours for a period.

Sport NZ is one of the largest single supporters of CNZ. In July 2024, the four-year Investment Initiatives were agreed with Sport NZ and will run until the end of our 2028 year. We have made substantial progress in all six of the development steps. These steps include the Incorporated Society re-registration process and improved governance, reviewing the organisational structure, developing club administrators, coaches, and volunteers, developing coach networks, relaunching the Secondary Schools program and extending to rangatahi with disabilities. However reduced government funding for Sport NZ means our funding is reduced by more than a third.

The Board has also been active in supporting the many volunteers who officiate at Tournaments. A new role of GC Umpire has been established to provide the additional first step in the progression Player, Umpire, Referee, Senior Referee. The provision of a Referee in Charge has been regulated. These steps supplement the new Tournament Manager's Manual introduced last year.

As this is my final Annual Report, I wish to acknowledge the many hours of work that Judith Hanratty CVO OBE has put in over the last four years. An acknowledged specialist in risk, constitutional law, and corporate governance she recognised early in the process of developing Constitutional templates that up to six Associations could have difficulty in reregistering under the 2022 Act. Judith changed CNZ's approach from "top down" to "bottom up." Teaming with Stefan Horrer and others she has put in a vast amount of work in researching and developing templates and answering queries for each of the three levels Clubs, Associations and CNZ. The CNZ Constitution is to be approved at the 2025 AGM before being sent for registration. The support she has provided to myself personally, CNZ and the WCF is evident in her work on many and diverse subjects including terms of employment, gender recognition and safeguarding to name a few. The latter two also serving as foundations for the WCF statutes.

Both Dallas Cooke and myself were elected in 2019 and Dallas has been a strong and capable Board member whose knowledge of Xero has been very helpful. Having served six years we will both leave the Board when the new Board is elected under the new Constitution. It has been a great honour to Chair the Board for almost the complete period of the 2020 constitution. With a new Chief Executive being recruited I have resigned as Chair. This allows the new Chair to be supported by Stefan and myself for the maximum time. With her knowledge, personality and experience I am sure Darla Blake will lead an even better Board. Transitioning to the new Constitution will require more elected members and encourage more candidates. The Board would also like to see Associations, through combination or collaboration, having Coach Tutors and Senior Referees in both codes.

Lastly, I congratulate Darla Blake on being elected Board Chair and wish her and the upcoming new Board the full support of New Zealand's croquet community.

LETTER FROM THE CHIEF EXECUTIVE



Welcome to the 2024-25 Annual Report

Croquet New Zealand (CNZ) continues to grow and evolve in exciting ways. Membership numbers are increasing, coaching qualifications continue to grow, helping players at all levels improve and enjoy the game, and participation in competitions remains strong.

However, qualifications of umpires and referees remain a concern, and will require more work in the years to come. Work is already underway with the Laws Committee initiating a new GC Umpire qualification which the CNZ Board approved during the

year. The new qualification only became available in February and has been a great success with over 30 new umpires qualified already.

A special thank you goes to our Tournament Committee, whose fantastic work planning and coordinating our tournaments, included supporting our tournament managers throughout the year. The Committee also developed new resources for managers, including a guide for CroquetScores, and a revised and comprehensive Manager's Guide will be available for this coming season. These tools have made and will make a real difference in the delivery of our events.

We've seen remarkable success on the competitive front. Jenny Clarke made history as the first female winner of the AC Open in 59 years. Levi Franks represented us proudly at the U21 GC World Championship winning the title in impressive fashion, and Katie Zentveld became the youngest ever winner of the Don Reyland Memorial Stars event.

We were saddened by the departure of our Inclusion Officer Oliver Field, and we acknowledge the ongoing importance of inclusion ensuring croquet remains welcoming and accessible to all.

The structural evolution of CNZ, undertaken through the reregistration under the Incorporated Societies Act 2022, is progressing well, with stronger integration from clubs to associations to the national body. While most clubs and associations understand and support this direction, a few outliers remain. We recognise that more work is needed to ensure alignment across the country. I would like to take the opportunity here to thank our Board Member Judith Hanratty who has worked tirelessly over the last 18 months to develop and draft constitutions for all three levels, provide detailed guidance notes and required resolution drafts for clubs and associations to use.

The final piece in the puzzle will be the CNZ Constitution which members have been consulted on and will hopefully approve at our Annual General Meeting in October. The new CNZ

Constitution presents a significant opportunity for members. Associations now have the chance to be more active and better represented. This will require commitment and responsibility from our associations, but it also opens the door for a largely new and more representative board to shape the future of croquet in New Zealand.

As I prepare to step down, I want to express my gratitude for the opportunity to serve. I will continue to play and stay involved, and I hope my successor as Chief Executive receives the same support I've been fortunate to have from members and I truly hope that she or he will have the support of the full board.

Thank you to all our volunteers—especially CNZ committee members, coach tutors, and those who give their time at associations and clubs. Your dedication is the backbone of our sport.

We also remember and honour the contributions of CNZ Life Member Geoff Young, Keith Ebden who was a key volunteer maintaining and improving the CNZ Database, and Eileen Judd, a regular tournament manager and/or referee at CNZ tournaments, whose loss is deeply felt.

Finally, my heartfelt thanks to CNZ staff and to board members Darla Blake, Dallas Cooke, Judith Hanratty and Tony O'Donnell for their unwavering support.

Sport Development Officer Report

The past year has marked a dynamic and transformative period for Croquet New Zealand, with considerable strides made across our strategic development pillars. Our focus on player development, coaching infrastructure, youth engagement, and media capability has delivered tangible progress and laid strong foundations for future growth.

Player Development Committee (PDC)

The establishment of the PDC has proven instrumental in galvanising CNZ's commitment to developing players at all levels. With dedicated working groups for Coaching Coaches, Secondary Schools, Youth Development, and High Performance, the PDC now serves as a central hub for strategic planning and operational execution. Aligned to CNZ's overarching goals, this initiative has brought clarity, cohesion, and momentum to our player development agenda.

Secondary Schools Expansion

After a pandemic-induced hiatus, youth engagement has rebounded with renewed energy. The launch of SSNZ-sanctioned Island events introduces inclusive formats that accommodate home schoolers, composite doubles pairings, and younger students — ensuring greater regional accessibility and environmental sustainability. The strategic repositioning from a national tournament to localised events reflects our commitment to growth through adaptability.

Coaching Coaches Program

A surge in coach development is being driven with the focus on a growing network of Coach Tutors, with the Upper North Island setting a benchmark in club-level coaching support. New tutors in the Central North Island and expansion into the South Island signal the next phase in building a robust national coaching framework. Six workshops and a target of 30% qualification achievement rate of workshop attendees underscore our progress.

Livestreaming & Media Production

Broadcast quality livestreams are gaining traction, thanks to volunteer support and strategic partnerships with Whakaata Māori and the NZ Sport Collective. These events not only enhance visibility but also serve as valuable coaching assets. The development of educational video content, including the Advantage GC scoring guide and TGfU "Rush" app concept, reflects our commitment to accessible learning tools.

Innovative Play - Advantage GC

Working alongside the Tournament Committee, the introduction of Advantage GC into national competition has sparked meaningful discourse and experimentation. While scoring refinements continue, the consensus is that this format offers a more intuitive and equitable approach for players of varying levels. This evolution is a testament to CNZ's appetite for innovation.

Community Milestones

- CNZ Merit Awards: 11 recipients recognised for excellence in Association Croquet
- Membership Growth: Surpassing 5,000 affiliated members nationwide
- Coaching Success: Highest workshop-to-qualification conversion to date

Conclusion

This year has showcased CNZ's ability to both consolidate foundational structures and push boldly into new territory. From operational advancements to inclusive programming and media advancements, the trajectory is unmistakably upward. I extend my heartfelt thanks to our volunteers, community leaders, and partner organisations whose support continues to fuel these achievements.

Together, we are cultivating a vibrant, sustainable, and inclusive future for croquet in Aotearoa.

COMMUNITY

Inclusion Report

In September 2024, Oliver Field stepped down from his role as CNZ's Inclusion Officer. Oliver was instrumental in launching the Inclusion Programme, collaborating with associations, clubs, and disability organisations to create meaningful opportunities for people with disabilities to engage with croquet.

While we have not yet hired a new Inclusion Officer our associations have continued to work with our partners in the disability sector with some of the highlights listed below.

Parafed Taranaki

In February 2025, the Tasman Croquet Club in New Plymouth worked with Parafed Taranaki and hosted 20 young players with disabilities to 'have a go'. It was an opportunity to showcase our sport and also put the new smaller and lighter mallets to good use. The mallets were purchased through grant funding and provided to the association by CNZ.

Halberg Games

In April 2025 Auckland played host to the annual Halberg Games at King's College. Croquet was once again part of this sports festival. Without Oliver, CNZ relied on local volunteers to run this national event, and Gillian Bannan and her team of helpers provided a fantastic opportunity for everyone, with various different games to showcase croquet for participants at all levels.

Parafed Bay of Plenty

Croquet Mount Maunganui hosted a group of 14 players from Parafed Bay of Plenty for a 'have a go', with some of the players returning or already members at clubs in the Bay of Plenty.


CNZ wishes to thank all the volunteers who helped carry forward the momentum Oliver started, ensuring croquet remains accessible to everyone. Inclusion plays a vital role in fostering stronger and more connected communities.

CNZ Membership

Membership across our 112 clubs has continued to grow with an increase of 2.9% to just under 5,100 players. This is still well short of the strategic target of 6,000 affiliated members by 2026, which is largely due to the impacts of Covid as can be seen in the graphs below.

The graph on the right shows the continued membership growth following the rebound after Covid from the 2021-22 season onwards. Net growth of 2.9% is slightly up from last year's 2.6%.






Gross membership growth reached again over 13%, but once again we also lost over 10% of our membership over the last year.

This percentage of members lost is a relatively consistent number over the years and I am sure clubs are familiar with and factor it into any membership growth initiatives they may undertake.

After years of decline in our youth / Under 21 membership, 2024-25 saw the numbers stabilising. The relaunch of the Secondary Schools Programme September and the last year, introduction of separate two competitions on each Island this year, should provide further opportunities in attracting Under 21 players making the competition more accessible by reducing travel costs. Some progress has been



made in 22-34 and 35-59 brackets with a combined increase by about 1% of total membership.

Qualifications

Laws

Attracting and retaining qualified officials continues to be a challenge across the country and across both codes of our games. While the challenges are particularly evident for AC, GC qualifications are not growing at the required level.

Following feedback received about the increased complexity of the GC Rules with every new edition, the Laws Committee undertook a review of the GC qualifications and requested the introduction of a new qualification of GC Umpire. The new qualification was approved by the CNZ Board in December, and the qualification was officially introduced in late January with the first GC Umpire qualifying in February. As of 30 June 2025 we have a total of 30 new GC Umpires qualified.

While this is a positive step in the right direction, we can only grow our umpire and referee numbers if we provide individuals with the opportunities to become qualified. Associations and clubs will need to provide those opportunities through the local examining referees.

We will continue to look at more new opportunities.

Association Croquet

The qualifications in AC Laws decreased during 2024-25 across all three qualifications. The number of Umpires decreased from 41 to 33, while the number of Referees decreased by one and Senior Referees declined by two.





Golf Croquet

The number of GC Referees rebounded slightly increasing by two, while the number of GC Senior Referees increased by three.

In addition, as mentioned above we saw 30 new GC Umpires qualifying.

Coaching


The development of new coaches continues to gain momentum. After increasing coaches numbers last year following the appointment of two coach tutors across Auckland and Northland, 2024-25 was even more successful.

The progress is most prominent with the Upper North Island with a total of 10 new qualifications (1 AC Coach and 9 GC Coaches), thanks to the fantastic work done by Coach Tutors.

During the 2024-25 season CNZ conducted six coaching coaches courses with 40 participants across the country, resulting in the qualification of three new AC Coaches and 13 GC Coaches.

This increased the number of our GC Coaches from 36 last year to 49, representing a 36% increase, and our AC Coaches from 10 to 13, or 30%.

Our Sport Development Officer continues building our coaching group, through identifying and developing additional coach tutors across the country and providing development opportunities for aspiring coaches.

This will require the continued support of clubs and our regional associations.

Overview

The 2024-25 season started off with the return of the Secondary Schools National Final held in Auckland. This was the first time the event was held in four years. Participation numbers continued to increase on prior year and it was particularly pleasing to see the strong support our AC Tournaments experienced. Once again, several players also competed on the international stage with the highlight being the GC Under 21 World Championship.

International Tournaments

The Chesapeake Bay Croquet Club in Virginia, USA, hosted the GC World Championship in October 2024, in which five New Zealand players participated. Three players, Jenny Clarke (Canterbury), Edmund Fordyce (Thames Valley) and Felix Webby (Hawkes Bay), reached the knock-out phase, with Edmund and Felix progressing to the last 16.

In February 2025 Launceston played host for the Openshaw Shield, the Tier 1 GC World Team Championship. Despite being the defending Champion, the New Zealand Team entered the event ranked fifth amongst the eight participating teams. Our team of Felix Webby (Hawkes Bay, captain), Edmund Fordyce (Thames Valley), Levi Franks & Logan McCorkindale (both Canterbury) and manager Nelson Morrow (Auckland) were drawn with host Australia, England and Ireland and managed to progress to the semi-final against the USA, which proved a hurdle too big to overcome. The USA, with the three most recent individual World Champions in their team, were too strong and ultimately went on to win the Openshaw Shield. Our team finished fourth in a close test match against Australia.

The highlight of the international calendar was the GC Under 21 World Championship held at the Sarasota County Croquet Club in Florida, USA, in April 2025. New Zealand was represented by five players, Jessica Bullen (Wellington), Mattie Clarkson (Counties Manukau), Luke Francis (Manawatu-Wanganui), Levi Franks (Canterbury) and Callum McKinnon (Wellington). The field included all the top U21 players with reigning GC World Champion and Openshaw Shield winner Blake Fields (USA), the highest ranked U21 player Jack Good (England) and 2023 finalist Fawzy Helmy. Four of our players reached the knockout stage, with Jessica Bullen going on to reach the Bowl Final where she lost to Jana Mohammed Saaid of Egypt. Levi Franks improving throughout the tournament, reached the final dropping only one game in the semifinal against Good and crowned himself World Champion winning the final in straight games against Helmy. This is the fifth win by a New Zealander to win the U21 GC World Championship in seven editions.

National Tournaments

Our national tournaments saw strong participation across both codes with AC in particular benefitting from participation by all our top players. The AC Open also saw the first female winner in 59 years with Jenny Clarke (Canterbury) taking the title at Mount Maunganui.


The GC Open saw Logan McCorkindale (Canterbury) win both the singles as well as the doubles alongside his brother Reece McCorkindale (South Canterbury). At the Terminator Mallets Under 21 GC Championship Levi Franks (Canterbury) won his third consecutive singles title, while Jessica and Nathan Bullen (Wellington) won the doubles event.

Tournament Participation

Participation in CNZ tournaments continued to grow overall by 8% following the 12% increase last year. AC Tournaments saw an increase of 5% following the 32% increase last year. While that increase might seem low it must be noted that during 2024-25 we did not hold the AC Club Team event which is only held every two years. Taking the Club Team Event into account participation for AC grew by 21 %. Participation in GC grew by 10.8% following a slight decrease of 2.6% last year.

Player numbers in CNZ tournaments this season were again relatively evenly distributed between AC and GC tournaments with 183 players competing in AC events across 8 tournaments compared to 205 in GC tournaments across a slightly higher number of tournaments of 10.



The Tournament Committee has continued to work on support for our tournament managers, releasing a guide on how to use CroquetScores last year. Before the start of the new season further support will be made available in the form of a new Tournament Managers Guide, and the direct support for managers will again continue this season with each manager being supported by two individuals appointed by the Tournament Committee.

Grant Providers

CNZ has continued to receive generous support from our established relationships with NZCT, Pelorus Trust, and Pub Charity, despite the overall decrease in grant funding available.

Sport NZ

Sport NZ continues to support CNZ with an annual investment. CNZ just completed the first year of the Investment Agreement with Sport NZ covering the period 2024 to 2028. CNZ appreciates the ongoing support, not just financial, by Sport NZ.

We would like to thank all our Partners, Sponsors, Grant Providers for their ongoing support.

FINANCIAL INFORMATION

After two years of losses following CNZ's decision to invest in Community Coaching and Development as well as the relaunch of our Secondary Schools Programme, CNZ budgeted another loss for 2024-25 mainly driven by International Tournaments.

The actual result for the year ended 30 June 2025 is a profit of \$31,154 compared to a budgeted loss of \$23,753.

This improved performance of \$54,907 compared to budget is driven by various factors which are summarised and explained below:

Strict cost control over travel and accommodation expenses across all parts of the organisation including for the Openshaw Shield. Taking advantage of booking airfares early, specials for accommodation, using free accommodation where available etc.	23,800
Strict cost control on Technology, Communications and Office expenses with significant savings in technology and postage/courier costs.	8,400
Other net savings	1,000

CNZ Income of \$349k was significantly below budget of \$388k, with grant income being significantly lower due to the Inclusion Officer partially offset by other unbudgeted grant funding received. In addition, \$11k of product sales did not eventuate following CNZ's decision to no longer sell equipment.

Actual Expenses of \$318k were significantly lower than budgeted expenses of \$411k, with salaries about \$46k below budget, while other expenses were also significantly lower than budget as outlined in the table above.

INDEPENDENT ASSURANCE PRACTITIONER'S REVIEW REPORT

To Members of Croquet New Zealand Incorporated

We have reviewed the financial statements of Croquet New Zealand Incorporated ('the Society') on pages 4 to 13 which comprise the statement of financial position as at 30 June 2025, the statement of financial performance, the statement of cash flows, and the statement of movements in equity for the year then ended, and notes to the financial statements, including the statement of accounting policies.

Board's Responsibility for the Financial Statements

The Board is responsible for the preparation and fair presentation of the financial statements in accordance with the Tax Administration (Financial Statements) Order 2014 and for such internal control as the Board members determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

This report is made solely to Croquet New Zealand Incorporated's members, as a body. Our review work has been undertaken so that we might state those matters which we are required to state to them in a review report and for no other purpose. To the fullest extent permitted by law, we do not accept or assume responsibility to anyone other than Croquet New Zealand Incorporated and Croquet New Zealand Incorporated's members, as a body, for our review work, for this report or for the conclusion we have formed.

Assurance Practitioner's Responsibility

Our responsibility is to express a conclusion on the accompanying financial statements. We conducted our review in accordance with International Standard on Review Engagements (New Zealand) (ISRE (NZ)) 2400, Review of Historical Financial Statements Performed by an Assurance Practitioner who is Not the Auditor of the Entity. ISRE (NZ) 2400 requires us to conclude whether anything has come to our attention that causes us to believe that the financial statements, taken as a whole, are not prepared in all material respects in accordance with the applicable financial reporting framework. This standard also requires us to comply with relevant ethical requirements.

A review of the financial statements in accordance with ISRE (NZ) 2400 is a limited assurance engagement. The assurance practitioner performs procedures, primarily consisting of making enquiries of management and others within the entity, as appropriate, and applying analytical procedures, and evaluates the evidence obtained. The procedures performed in a review are substantially less than those performed in an audit conducted in accordance with International Standards on Auditing (New Zealand). Accordingly, we do not express an audit opinion on these financial statements.

Other than in our capacity as assurance practitioner we have no relationship with, or interests in Croquet New Zealand Incorporated.

Notes to the Financial Statements

1. Statement of Accounting Policies

These financial statements are special purpose financial statements and have been presented in accordance with the Tax Administration (Financial Statements) Order 2014. Croquet New Zealand Incorporated (CNZ) is an Incorporated Society registered under the Incorporated Societies Act 1908 and a not-for-profit Entity.

A. GENERAL ACCOUNTING POLICIES

The general accounting policies recognised as appropriate for the measurement and reporting of results and financial position under the historical cost method, are followed in the preparation of the financial statements.

B. PARTICULAR ACCOUNTING POLICIES

The following particular accounting policies, which significantly affect the measurement of financial performance and financial position, are applied.

Depreciation

Depreciation is calculated at the maximum rates approved for taxation purposes. The rates and methods applied are as set out below:

Office equipment	20	to	60%	Diminishing Value
Fixtures and fittings	9	to	20%	Diminishing Value
Croquet equipment	20	to	25%	Diminishing Value
Vehicle			30%	Diminishing Value
Streaming equipment			40%	Diminishing Value

Amortisation

Amortisation of intangible assets is calculated using rates so as to allocate the costs of the assets over their useful life.

Database 20% Straight Line

Intangible Assets

The intangible assets of Croquet New Zealand are stated at their amortised historic cost.

Fixed Assets

Fixed Assets of Croquet New Zealand are stated at their depreciated historic cost. Fixed assets with a purchase price of \$1,000 or less are expensed on acquisition.

Accounts Receivable

Accounts Receivable are stated at estimated realisable value, after due allowance for amounts which are not considered recoverable.

1. Statement of Accounting Policies (Cont'd)

Goods and Services Tax (GST)

All revenue and expense transactions are recorded net of GST. Where applicable, all assets and liabilities are stated net of GST with the exception of receivables and payables which are stated inclusive of GST. Cash flows are presented including GST where applicable.

Income Tax

The Council is tax exempt under the Income Tax Act 2007 for promoting an amateur game and sport.

Interest Income

Interest income is accounted for as earned over the term of the financial instrument.

Inventories

Inventories are valued at the lower of cost on an average cost basis, or net realisable value after due allowance for obsolescence.

Term Deposits

Term deposits are recognised as Investments on the balance sheet when the term is greater than the period of 90 days.

Revenue

Revenue derived from levies, yearbooks, national tournaments and equipment sales is recognised on an accrual basis. Revenue through grants is recognised when the funds are received in the bank account unless there are unmet conditions, in which case they are carried forward as income in advance.

C. CHANGES IN ACCOUNTING POLICIES

There have been no changes in accounting policies. All policies have been applied on bases consistent with those used in previous years.


